

Eligibility Criteria to Undertake an Advanced Technical Test

1. The Scheme is supported by a cache of trained, experienced and qualified Testers. It is essential that Testers working within the Scheme are fully experienced in the operations, use and typical application of that category of plant. Those wishing to become Testers within CPCS must have relevant experience on the category, and are trained and assessed in order to successfully, independently and impartially judge an individual's skills, knowledge and understanding through an assessment process.
2. Those seeking to add a category of plant to a Tester Card must have a minimum number of operating hours on the category, please refer to Appendix A. If a category does not require operating hours a Record of Experience does not need to be completed as long as the guidance in Appendix A is followed. Operating experience must be recent, valid, reliable and authenticable, and attained carrying out productive work through a normal job role within the construction or allied sectors; relevant to the category. As a guideline, the majority of declared hours on the category should be within the last five years.
3. The hours apply only where the item of plant is actually being used for operational work such as excavating, lifting, compacting etc. Time taken for pre-use checks, configuring for work and de-configuring/readying for transport can be included. Activities such as driving to and from the workplace, downtime between work or maintenance-type work does not constitute part of the required number of hours.
4. Evidence detailing both training and post-training experience in the particular category of plant must be provided prior to the Advanced Technical Test taking place and all information required by the form identified. The Record of Category Experience document must be completed by the applicant. Only the details for one category can be recorded on this document. Other categories can be applied for using fresh documents. The applicant will sign the document confirming that the information supplied and supporting evidence is valid and reliable.

Record of Category Experience Completion

5. The Record of Category Experience must be completed and submitted to the nominated CPCS Accredited Centre at least two weeks in advance of the proposed test day for checking to ensure that:
 - The minimum number of hours have been recorded prior to notification.
 - The information detailed on the document and any supporting evidence meets the criteria detailed in paragraphs 2 and 3 of this document.
 - That the document has been signed by the applicant.
6. The CPCS Accredited Centre once satisfied that the information provided is reliable and meets the eligibility criteria laid down to undertake the advanced technical tests, will forward the document to the relevant NOCN Job Cards EQA for approval **via email** allowing sufficient time for any further checks to be carried out if necessary.
7. Once approved the NOCN Job Cards EQA will advise the CPCS Accredited Centre by **email**, and arrangements will be made to agree the actual date of the advanced technical tests.
8. The CPCS reserves the right to question the applicant and/or request additional supporting information prior to or after the test, and refer the Record of Category Experience to the CPCS Product Office if need be, who will appoint a subject matter expert to scrutinise the application. When this happens, the test will not take place until authorised by the NOCN Job Cards EQA. The category of plant may be removed from the test card should subsequent investigations reveal that the applicant did not meet the criteria detailed in paragraphs 2 and 3.
